CHIEFS REPORTS

Chief Burgess reported the District received notification indicating it will receive an unbudgeted, unexpected, reimbursement from GEMT for \$692,779 before the end of the year. Chief Burgess proposed a meeting with the Finance Committee to discuss prioritization and spending of these one-time monies. District staff will schedule a Finance Committee meeting in November.

QUARTERLY FINANCIAL REPORT

Danette Weyn presented the Quarterly Financial Report for quarter ending September 30, 2019. A brief discussion followed.

OLD BUSINESS

A. 2020 Budget – Revenue Hearing. As required by RCW 84.55.120, Chief Burgess presented the Revenue Hearing explaining, in detail, the types of revenues and their sources for collection throughout the budget year.

B. 2020 Budget – Final Draft. Chief Burgess presented the Board with the final draft of the 2020 Budget, reviewing only a few minor changes incorporated since presentation of the second draft.

C. 2020 Budget Resolutions. Chief Burgess indicated the final budget for 2020 will be presented for formal adoption at the November 12, 2019 meeting. Chief Burgess then reviewed the resolutions and levy certificates required to adopt the budget, explaining the purpose of each resolution and certificate presented. Chief Burgess also advised the Board that the draft resolutions and certificates have been reviewed and approved by both the Pierce County Auditor's office as well as the District's legal counsel.
