Chief John Johnson gave a brief COVID19 update, numbers continue to rise. Mobile testing will be available at Gig Harbor High School on November 20. Many states are rolling back and increasing restrictions. Pfizer reports their vaccine is 90% effective in trials and is working on a roll out plan.

Chief Watson reported predesign drawing for Stations 58/59 were sent to the Fleet and Facilities Committee and plans are being made to schedule planning Workshops with the architect in November and December.

DC Waters recommended that the Board consider expanding community access to District 5's legislative process using livestream technology. The Board had several questions for District

staff and requested additional research and a report at the next meeting.
