#### CHIEFS REPORTS

Chief John Johnson gave a brief update regarding current COVID19 numbers and vaccine distribution information.

Chief Todd Meyer reported the PCSORT/PCHIT group is in the process of finalizing a contract to hire a consultant that will perform a GAP analysis and evaluation of the special operations in the County to get a better picture of the work these teams are doing.

Chief Todd Meyer reported regarding the recent snowstorm and its impacts in our District. The logistics division provided a lot of support before the storm, and were able to plow parking lots in our facilities during the storm. Station 53 was staffed up Thursday to Sunday with a brush truck and three person engine company. Call volumes were not as high as expected, but the crews had good interactions with the community over the weekend.

#### PEER SUPPORT PRESENTATION

Battalion Chief Scott Booth was in attendance and presented a Peer Support Program update on the status of our Peer Support Program, the work the peer supporters do, and the benefits to the District. Chairman Wilsie thanked Chief Booth for his work not only in Gig Harbor but in Pierce County.
