May 25, 2021

Chairman Wilsie called the virtual Zoom meeting to order at 5:00 p.m.

APPROVAL OF THE AGENDA

Commissioners Entze and Nelson moved and seconded to approve the agenda as presented. With no further discussion, the MOTION CARRIED by unanimous roll call vote.

- The IT consortium with Central Pierce has been meeting to work out cost allocation and is working to develop a scope of work
- District staff will be presenting an updated fee schedule at the June 8 meeting
- He approved a request from Division Chief Calvin Johnsonto have Narcan on all front line apparatus

STANDING COMMITTEE REPORTS

FINANCIAL REPORT

Chief Bjurstrom presented a new format of financial report and requested input from the Board. Discussion followed.

NEW BUSINESS

- a. Resolution 2021-10 Voucher Approval. Chief Langlow presented Resolution 2021-10 to update who is authorized to approve vouchers, previously it identified individuals by name, now it identifies by position. With no further discussion, Commissioners Nelson and Urvina moved and seconded approval of Resolution 2021-10 as presented. The MOTION CARRIED by unanimous roll call vote.
- b. Resolution 2021-11 Banking Signature Authority. Chief Langlow presented Resolution 2021-11 updating the persons with bank signature authority. Commissioners Entze and Nelson moved and seconded approval of Resolution 2021-11 as presented. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.
- c. Standard of Cover/Community Risk Assessment. Chief Bjurstrom presented a contract with Dynamix for services to prepare a standard of cover and risk assessment as an unbudgeted item. After a brief discussion, Commissioners Urvina and Nelson Sutich moved and seconded approval of the contract as presented. With no further discussion, the MOTION CARRIED by unanimous roll call vote.
- d. Bid Results Generator and Automatic Transfer Switch. Chief Johnson reported the District received two bids to replace an aging generator at Station 56, the lowest bid coming from Legacy Communications. After a brief discussion, Commissioners Nelson and Entze moved

and seconded a motion to accept the bid from Legacy Communications in the amount of \$87,177.16. The **MOTION CARRIED** by unanimous roll call vote.

OPEN PUBLIC COMMENT

John Hargroves, resident of Gig Harbor spoke in favor of the District's plan to update its standard of cover and also said his previous experience with Legacy Communications and had some COVID questions.

Assistant Chief Eric Watson thanked the Board and said he has enjoyed his time working with the current Board and all of his years with the District. The Commissioners took turns thanking Chief Watson for his years of dedication with the District.
