- Retired Chief Burgess is willing to assist with 2022 budget planning, will be scheduling a meeting soon
- Assistant Chiefs are almost fully transitioned into their new roles
- Staff participated in a Standard of Cover kickoff meeting with Dynamix last week
- Had lunch with Rep. Jesse Young last week and meeting with Senator Emily Randall next week
