CHIEFS REPORTS

Chief Bjurstrom:

- Gave a brief COVID19 update and said he anticipated an additional update at the July 13, 2021 meeting;
- Reported regarding a structure fire on Reid Drive
- Reported regarding the Districts appreciation for an off duty Puyallup police officer who responded to a gunshot wound victim helping expedite transport by our crews

Chief Doan reported:

- District Staff's number one goal is to provide a capital needs assessment to the Board by October, as such staff are working with Dynamix to complete the Standard of Cover and looking at contracting with Intterra for data analysis software to be addressed during New business
- He had a meeting with Central Kitsap Chief Oliver and South Kitsap Chief Faucett,

looking at some potential partnerships between the Districts and how they can benefit eachother

- He has met with local elected and has received verbal support of the District's needs for capital funding support
- Negotiations for 4th Platoon will be taking place soon, meeting dates have been scheduled to move forward
- We have started the 2022 budget process and met with Chief Burgess to get some advice and a budget timeline has been drafted
- The IT Consortium is working on finalizing an ILA and we hope to have it for presentation at the next meeting
- A hiring notice for entry level firefighters, lateral firefighters and lateral paramedics has been published
- He has been asked to participate in judging the maritime parade on August 21, 2021
- He will be Duty Chief over the 4th of July weekend and is planning to assist the B/Cs

STANDING COMMITTEE REPORTS

Commissioner Entze reported the Labor Management Committee held a preliminary meeting to discuss upcoming negotiations for 4th Platoon.

FINANCIAL REPORT

Chief Langlow presented a financial report, asking if the format meets the needs of the Board or if there are any requested changes. Commissioner Nelson commented he really appreciates having a single page report and suggested including a year over year column.
