COMMISSIONERS' MEETING MINUTES

August 24, 2021

Chairman Wilsie called the virtual Zoom meeting to order at 5:00 p.m.

APPROVAL OF THE AGENDA

Commissioners Entze and Nelson moved and seconded to approve the agenda as presented. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.

COMMISSIONER ABSENCE

Commissioners Sutich and Nelson moved and seconded to approve Commissioner Urvina's absence from tonight's meeting. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.

COMMUNICATIONS

MINUTES AND BLANKET VOUCHERS

Commissioners Entze and Nelson moved and seconded to approve Minutes of the August 10, 2021 regular meeting. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.

Commissioners Nelson and Entze moved and seconded to approve the vouchers as set forth in the agenda for a total consideration of \$357,777.91. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.

LOCAL 3390 REPORTS

President Flick reported the Local's body approved the vote for 4 Platoon with 98 yes votes, 7 no votes and 6 members abstained. President Flick also thanked everyone involved in the Eliza Hoover memorial process and commented it is great to be part of such a supportive agency.

CHIEFS REPORTS

Chief Bjurstrom:

- Gave a brief COVID19 update
- Reported that Abe Edmonson will begin work as a Prevention Support Specialist on September 13, 2021; D/C Waters is working on a training schedule

Chief Langlow:

• 2022 Hiring update – 76 individuals have been selected to move forward in the 2022

hiring process

- Current entry and lateral new hires are progressing well; three laterals should go to shift mid-September and seven entry level candidates will go to shift after completion of EMT class, likely in November
- Dynamix representatives are on site this week, they anticipate project completion in October, if not sooner; a community survey will be distributed

Chief Doan:

- Thanked the Board and numerous District staff for their support and work over the last few weeks in honoring Eliza Hoover
- Reported District staff are meeting with Union representatives to negotiate impacts of Proclamation 21-14/mandatory vaccine

FINANCIAL REPORT

Commissioners Nelson and Entze moved and seconded approval of Resolution 2021-16. With no further discussion, the MOTION CARRIED by unanimous roll call vote.
- b. IT Consortium ILA. Chief Doan recommended the Board approve the IT Consortium ILA as proposed. After a brief remark by Chairman Wilsie, Commissioners Sutich and Entze moved and seconded approval of the agreement as proposed. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.
- c. 24-Hour Shift Reorganization. Chairman Wilsie requested this item be brought back before the Board during the September 14, 2021 meeting. This will allow the public to have additional time to review and ask questions as well as have Chairman Urvina present for the vote.
