- Intterra implementation continues decision has been made to use only ESO data due to issues bringing Zoll historic data over; have requested dashboards for Commissioners' use
- District has received a draft Standard of Cover from Dynamix, District staff is reviewing; Dynamix will be presenting final to the Board during October 26 Board meeting;
- Capital Facilities Plan will be presented again at November 9 Board meeting, will be bringing before the Board again for approval on December 14
- District email is down, hopefully will be back online soon
- Chief Langlow is rolling back to Battalion Chief on January 1, 2022; have candidate here this week for a site visit; if that does not work out, will conduct a full hiring process
