FINANCE REPORT

- a. Capital Facilities Plan. Chief Doan presented regarding the District's Capital Facilities Plan ("CFP") and requested the Board adopt the CFP as prepared by Rice Fergus Miller. After some discussion, Commissioners Sutich and Nelson moved and seconded adopting the CFP prepared by Rice Fergus Miller. With no further discussion, the MOTION CARRIED by unanimous roll call vote.
- b. Chief's CFP Recommendations. Chief Doan presented regarding his recommendations for capital facilities planning.

NEW BUSINESS

- a. Resolution 2021-28 Expense to Reserve Fund Transfer. Chief Langlow presented Resolution 2021-28 with a recommendation the Board adopt as proposed. Commissioners Sutich and Nelson moved and seconded approval of Resolution 2021-28 as presented. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.
- b. Resolution 2021-29 Surplus Equipment. Chief Johnson presented Resolution 2021-29 with a recommendation the Board adopt as proposed. Commissioners Nelson and Entze moved and seconded approval of Resolution 2021-29 as presented. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.
- c. Collective Bargaining Agreement Uniformed Personnel. Chairman Wilsie and Chief Doan advised the Board regarding the revised contract proposed. Commissioners Urvina and Nelson moved and seconded approval of the Collective Bargaining Agreement for Uniformed Personnel as presented. With no further discussion, the MOTION CARRIED by unanimous roll call vote.
- d. December 28, 2021 Board Meeting. Chairman Wilsie proposed canceling the December 28, 2021 Board meeting. Commissioners Sutich and Nelson moved and seconded cancellation of the meeting. With no further discussion, the MOTION CARRIED by unanimous roll call vote.
- e. Oaths of Office. Chief Doan swore in Commissioners Entze and Nelson for their newly elected six year terms beginning January 1, 2022.
- f. Committee Assignments. Discussion was held regarding committee assignments for 2022.
- g. Elections. Commissioners Sutich and Nelson moved and seconded appointing Alex Wilsie Chairman of the Board for 2022. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote. Commissioners Wilsie and Nelson moved and seconded appointing

Tom Sutich as Vice Chairman of the Board for 2022. With no further discussion, the **MOTION CARRIED** by unanimous roll call vote.
