Notice is hereby given that sealed bids will be received by Gig Harbor Fire and Medic One (Owner), Gig Harbor, Washington, for:

Gig Harbor Fire & Medic One HQ Interior Improvements and Roof Repairs

First Publication October 22, 2024, and Second Publication October 29, 2024 “Seattle Daily Journal of Commerce” and “The News Tribune”.

Sealed bids will be received by Gig Harbor Fire and Medic One up to but not later than **2:00 pm, November 20, 2024**, at the address listed below. The bids will then be publicly opened, recorded, and read in the conference room and online via the District’s website. The link for the bid opening is located on the District’s website at <https://www.gigharborfire.org/about/bond/>. **Bids received later than 2:00 pm will not be considered.**

The engineer's estimate for construction cost of the Roof Repairs is \$303,209.00, HVAC Equipment Replacement is \$700,000.00, and Interior Improvements is \$1,208,912.00, not including sales tax. **It is the Owner’s intent to award a single contract for the HQ Interior Improvements and Roof Repairs project scope of work.**

PRE-BID MEETING: A non-mandatory pre-bid conference will be held at Gig Harbor Fire and Medic One, Headquarters Administration Building, 10222 Bujacich Rd NW, Gig Harbor WA 98332. The conference is intended to provide prospective bidders with a general review and opportunity to visit the project sites prior to submitting bids. This pre-bid meeting will take place on **November 5, 2024, at 9:00 am.**

QUESTIONS: All questions regarding the project (including prior to, during, and after the site visit) shall be submitted via email with subject line “Gig Harbor Fire and Medic One HQ Interior Improvements and Roof Repairs: Bid Question” to Howard Struve (hstruve@rfmarch.com) at Rice Fergus Miller. Questions received via phone or any other method other than email will not be accepted. Bidders shall submit questions no later than **12:00 pm, November 12, 2024**. Receipt of questions will be acknowledged; however, all bidder questions will be answered via Addenda.

BID BOND REQUIREMENT: Each bid shall be accompanied by a bid bond in the form of certified check, cashier’s

check, or surety bond in an amount equal to at least 5-percent (5%) of the amount of such bid proposal. Checks shall be made payable to the Gig Harbor Fire and Medic One. Should the successful bidder fail to enter a contract and furnish a satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited.
